We want you to join us in recognising the valuable support the Centre provides and consider how you can help to raise much appreciated funds while also celebrating the year.



How will your support help?



Our clients are at the centre of everything we do and the funds you raise make a vital contribution to the care and support we provide at St Wilfrid's Centre

Whether you are an individual, part of a group, a school, a church or a company, you can fundraise in many different ways

Do tell us about your event <u>www.stwilfridscentre.org/ways-to-help#fundraising</u> so that we know it's happening. We can help promote your event and we can provide fundraising materials, from t-shirts to stickers.

- Guess the number of sweets in a 3kg bag or a jar. Charge a small amount per guess, with the sweets as the prize for the winner.
- Tea and coffee mornings are a good way to get people together. You can add extra treats, like hot chocolate with cream, biscuits or cakes to raise additional funds.
- Bake sales enable people to show off their cooking while also raising money for St Wilfrid's Centre. You can add an element of competition by providing prizes for the best bakes, such as the best decorated cake to celebrate the 30th Anniversary.
- Sponsored Walks can be simple events to organise with a bit of planning. Make sure you have a clearly marked route. Have a refreshment stall or hold a barbecue or picnic at the end to raise extra funds.
- Packing supermarket shopping by contacting your local supermarket and organising a rota of volunteer bag packers. Make sure there is a clearly visible collection tin or bucket and wear St Wilfrid's Centre T-shirts (available on request).
- Collect 20p pieces. Each 20p pays for a mug of tea at the Centre so see how many mugs of tea you can collect in a jar. Have a competition with your friends or create a picture on the floor using the 20p pieces and send in a photograph.
- Collect money from recycling. Cut down on landfill waste while also raising money for St Wilfrid's Centre. Cans for recycling soon mount up and mobile phones and electronic items can generate larger amounts so try collecting as a group.
- Horticulture Competition. Offer prizes for the best specimens grown. Keep it simple and/or add it to another summer fundraising event.







- Get crafty by start selling online homemade gifts. If you have developed a new skill in lockdown or have made handmade gifts, list your items cheaply on Etsy or ebay to raise funds.
- Give something up for January (or any month). A good way to get healthy and support the Centre. Whether you give up smoking, drinking, chocolate or swearing, as well as getting sponsored, you could add up any money saved and donate this at the end of the month too.
- Cycling. As well as taking part in cycling races that cater for all entry levels, think about cycling to work for 30 days or 30 weeks or plan a 30-mile cycle route for you and your friends. Ask people to sponsor you and donate any money saved on fuel or travel.
- Raffles. Not only are these easy to organise but are very popular. Ask around and ask your friends, congregation or local businesses for prizes
- Running Events. Whether you take part in a 5k or a marathon, running events are a great opportunity to ask for sponsorship. Make sure you wear St Wilfrid's Centre T-shirts (available on request).
- Dress down days. Whether you choose casual clothing, wear something yellow or make it a fancy-dress event, dress down days are popular. You can charge people a small fee and charge people a fine if they forget to take part.
- Sponsored Swim. Whether outdoor or using your local pool, swimming can be a great way to raise money.
- Charity dinner party. Host your own dinner party, charging your guests to taste your cooking. If you want friends and family to join in, you can all host your own Come Dine With Me event and score the evening and the cooking.
- Book sale. Ask your school, your church, your family, your neighbour, and friends to donate books that they no longer read. These can then be sold to raise funds.
- Bring and buy sale or Jumble Sale. Gather sellable items from your attic or from your neighbours and friends and do some good charity fundraising by putting on a sale. You could invite other people to set up a stall at a minimal charge. All you have to do is inform people about the event and on the day, you just need a few tables people who can manage the selling and money.
- Charity Car wash. With your friends or other volunteers, choose a community place or a door-to-door option.

 Offer to wash cars for a reasonable charge, and you will see people queuing to get it done.

- Karaoke. Rent or borrow a karaoke machine and hold a fundraising event in a local venue, or even in your garden.
- Obstacle Course. Set up your own obstacle race or use an existing venue. Sell tickets for people wishing to watch the contest and you could always sell refreshments during the event.
- Bingo or games night. This is an old favourite as most people like to play games and have fun at the same time.
- Sponsored cleaning or litter picking Cleaning litter in public places is a good fundraising idea to get donations. Gather some people to volunteer and get sponsors. Make sure there is a clearly visible collection tin or bucket and wear St Wilfrid's Centre T-shirts (available on request).
- Sponsored outfit. Let people choose what outfit you should wear for a day or any length of time. For this, they pay a sponsorship fee.
- Charity Auction. Get local businesses to make donations and arrange a venue, sell tickets, get refreshments in place and hold an auction.
- Annual Collection As an individual, family, or group just have a donation box and keep making donations when you come across an unspent coin or note in your pocket.
- Ugly Jumper competition Offer prizes for the ugliest or funniest jumper worn and allow your group to vote for the winners.
- Challenge 30. Set yourself and your friends a challenge. Walk 3 miles each day for 10 days, cook 30 meals, visit 30 football grounds or bake 30 cakes. There are bound to be lots of fantastic challenge 30 ideas that you can come up with to raise money for the Centre.
- Worm charming Grab people's attention people by dividing a grassy area into parts, on which each participant must bring out worms and collect them. The person with the maximum number of worms wins. Charge an entry fee. The prize can also be sponsored.
- Gift Aid. Don't forget to make sure that people give you all the necessary details and sign the declaration in order for you to claim an extra 20% gift aid on donations. See Gift Aid.
